- Must be Energy Star Rated
- EF > 2.0 (Check to make sure Heat Pump qualifies)
- Sign Application

By participating in The City of Chaska Rebate Program, you can discover ways to save energy and earn a rebate when you purchase a Qualified Heat Pump.

What Rebate Can I Earn?

2 Size Categories for Heat Pump Water Heaters (HPWH)

Qualifying units with Energy Factor of 2.0 or higher

HPWH Less than or Equal to 55 gallons = \$150

HPWH greater than 56 gallons = \$300

Fun Fact About HPWH Efficiency:

HPWHs' can be as high as **3x** more energy efficient over traditional methods (electric & natural gas) & is on average 19% of total household energy use!

How do I Qualify?

- Must have an E.F (Energy Factor) of 2.0 or higher.
- Customers receiving electric service from the City of Chaska Electric Department are eligible for a rebate when they purchase a qualified heat pump water heater.
- Information on rebate application must match information on receipt/ invoice exactly.
- The program is applicable only for the purchase of new equipment, for installation in new or replacement applications where the electricity is supplied by City of Chaska Electric Department.
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Rebate applications must include complete contractor and equipment information with a copy of dated sales receipt/invoice including manufacturer, model number, serial number; specifications including EF (Efficiency Factor). Incomplete rebate applications will not be processed.
- Rebate requests are processed on a "first-come first-served" basis and rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time. The customer is responsible for checking with City of Chaska Electric Department to determine whether program is still in effect & qualifying customers must apply for rebate by November 30, 2026.
